Terms and conditions

1. Information regarding prizes and how to enter forms part of these conditions. By entering, entrants accept these conditions.

Eligibility to Enter

2. Entry is only open to Australian residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to provide written evidence of consent to the minor entering this promotion. Entry is not open to Jean Hailes staff.

Promotion period

3. The promotion commences at 8:00am AEST on 25/04/2020 and ends at 11:59pm (AEST) on 31/07/2020 ("Promotional Period").

How to Enter

4. Entrants are required to register an event for the Women's Health Week 2020 campaign.

To enter, Entrants must complete the following steps during the Promotional Period: a) complete the registration form at www.womenshealthweek.com.au (b) input all the required details included on the form.

5. Entrants may register as many events as they plan to host provided each event is authentic and registered separately and in accordance with the entry requirements. Only events that have been approved by Jean Hailes are eligible to enter.

6. The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid.
